WELCOME TO OUR PROGRAM!!!!

The Extended Day Program at Christ the King is operated as a service to the families/children (K-8) of our school. Our program is another way of meeting the needs of today's working parents and to keep the children in a safe and happy environment. Only students enrolled at Christ the King school for classes may use the program on days that they **attend** school; **the program does not operate on days school is not in session.**

HOURS OF OPERATION

The hours of operation are: Morning Extended Day -- 6:30 a.m. to 7:15 a.m. in the school library for K-8 students. Extended Day -- 2:30 p.m. to 6:00 p.m. in the Parish Hall for K-8 students **on days that school is in session. The Extended Day Program is closed for the following reasons:**

1) adverse weather conditions or another emergency; 2) regular school holidays; 3) conference or in-service days. Every child needs to be picked up by 6:00 p.m. If a child remains past the closing time, a fine will be assessed at the rate of \$1.00 per minute/per child. Children are prohibited from the program if they have been made to wait a third time for a ride after 6:00 p.m. This policy is enforced immediately upon the third violation.

FEES

Fee for the Extended Day program is \$5.25 per hour per child. Again, if a child remains past the closing time, a fine will be assessed at the rate of \$1.00 per minute/per child. These charges are calculated every two weeks. **Payment is expected prior to the next statement** and will be billed through your FACTS account. Snack cards may be purchased for \$10.00 for 20 snacks. An *individual* snack may be purchased separately at a cost of .50 cents each.

A \$10.00 per student/ \$20.00 per family Activity Fee, covering supply costs, will be charged annually.
